I am writing this month's message looking out at beautiful blue skies and trees in full blossom. This reminds me of the great connection with nature we have through soaring. I think this is one of the strongest pulls to soaring – it is like fly fishing for air. The thrill and challenge of taking a low level thermal out is truly amazing. We really are lucky to be able to participate in such a great hobby. The soaring season in Colorado is off to a great start. It looks like spring promises outstanding lift (unfortunately the usual serious sink as well) with the large temperature differentials between night and day. As usual I hope everyone has been able to get out and take advantage of the conditions.

Relative to club items, the voting is open on the contest rules change proposal and a year-end proposed rules change. Please hit the web site to vote. The other option is to vote by regular mail. Please vote or postmark your vote to me by May 15th as that is the "Polls Closing Date".

As an update to the fee change proposals it looks like we are settling in on increasing the contest fees to \$10 for Masters with no change for Novice and Sportsman and a small increase for the Hand Launch events. We should have all the fee changes finalized by next month, but for upcoming May contest we will implement the \$10 fee. Thanks for everyone's great input on this important subject.

The sod farm is completely harvesting the East field we have been flying on for the past couple of years so we are moving to the West field for ALL FLYING. This is effective immediately. The club winch trailer is still stored on the East field with the sod farm equipment as there is supervision on site for the equipment. As a reminder if any members would like to use the winch equipment all that is required is to check in with the club winch master (me) for a safety and usage briefing, bring your battery and go. All that is asked is you return the equipment as you found it and if any mishaps occur please let me know ASAP. So it can be corrected.

On the contest front we have F3J in the Rockies coming up over Memorial Day weekend. There are still openings on the winch teams and of course two-man tows. We have some towers available so please get signed up and let Jim Monaco know if you are looking for some tower support.

Finally the Mentor Day season will kick off in June as apposed to May. We have great support from our members distributing over 300 flyers to all the Denver metro hobby stores. Relative to mentor support, I have every month covered with the exception of July 14. I need someone to STEP UP and lead this day. We should have backup support, but I need a committed lead. Please let me know ASAP.

That's it for this month. I hope this message finds everyone truly able to enjoy the local soaring conditions, and I wish all your families the best!

IN CASE YOU MISSED IT

The sod farm has harvested most of the grass on the East field so we will be switching all flying to the West Field at the corner of 120th and Tower Road. You enter off Tower about 1 block North of 120th. Steve tells me Thermals Page 1 of 10 there is quite a bit of water on the road back to the field, but the sod farm manager is going to do a little grading and things should dry up soon. This is effective immediately.

The club winch trailer will remain with the sod farm equipment on the east field, as there is supervision there. It is still ok of course to pick up winches and then drop them back at the trailer when finished.

I never saw it again. Expensive lesson. It was orange, and had my name etc. on it. It would be nice if it turned up someday. In the future I will use spotters if available. I won't let it get "that" small. I will take the rubber band off the flap control, and use the flaps to get down if I am too high, and I will try to avoid flying overhead.

ROCKY MOUNTAIN SOARING ASSOCIATION FIELD RULES

- 1. The sod farm operations take precedence over **ALL** activities. We use the field at the convenience of the owner.
- 2. All members will follow **ALL** instructions from **ANY** sod farm personnel without question.
- 3. When sod farm operations are occurring during a flying session it is **OUR** responsibility to ensure that we will not interfere with operations. If it is unclear as to what is happening or where they intend to mow or work try to talk to workers or management and always move equipment or vacate the premises if necessary. Some workers do not speak very good English in that case you must make every effort to avoid conflict or interference with operations.
- 4. Park only in the designated parking areas Do not park on grass, dirt or roads.
- 5. Avoid setting up on newly seeded areas or young grassy areas. The nice grassy areas are better to land on anyway!
- 6. Establish a frequency control pole and tag system! Frequency control is to be in effect at all times!! All members will post their frequency control tags on the pole and if there are conflicts, please exercise safety sense as well as share the flight time.
- 7. Parking and pit areas should be as condensed as possible for the safety of launch and landing.
- 8. Establish flight line areas for winch launch, high start launch, and hand launch that are separate for the sake of launch, flight & landing safety.
- 9. Flying over the parking/pit areas at less than 30 feet is prohibited. Doing so in competition WILL result in a zero flight score and during R/R flying a disciplinary action by the club.
- 10. No aerobatics or speed runs over the parking/pit/Launch/Landing zones.
- 11. Do not launch if a plane is circling in a launch zone: vacate the launch zone as soon as possible if someone is waiting to launch.
- 12. When entering a thermal occupied by other aircraft, enter in the same direction as the first aircraft
- 13. Landing aircraft have the right of way!
- 14. In the event of no mechanical retriever, please shag your own chute/line for the flight
- 15. Please share the usage of club equipment so that all have equal flight time.
- 16. Please be courteous and helpful to your fellow flyers as well as informative to all guests/spectators. Enjoy yourself and others!!
- 17. Absolutely no debris or trash is to be left on the field! Please take it home with you for disposal.
- 18. Make sure that your plane and electronics are airworthy before each flight. Exercise good safety sense in your flight
- 19. The aircraft will have an identification name/address or AMA number on or in the model in case of loss.
- 20. You MUST tag your winch/high start spikes or stakes with fluorescent tape so they are easily spotted on the field by all concerned. Members may be fined \$10 for each stake or nail not so marked. Previous damage to sod farm equipment from spikes left in the ground have made this rule EXTREMELY important.
- 21. Absolutely no alcoholic beverages will be consumed, prior to or during participation in any model event on the flying field.
